# DESCRIPTION

The DIGITAL Device Access Software (DAS) for RSLinx allows BASEstar Open users to access data table memory and shared data memory on Allen-Bradley PLCs, connected via the RSLinx software package by Rockwell Software.

BASEstar Open Data Services provide device-independent access to shop floor data allowing users to access data by getting or putting the value of one or more Device\_Data\_Points. A request to locally-emulated devices can generate an unsolicited event.

By means of BASEstar Open Data Services, a user or application can:

- Send read and write commands to Allen-Bradley devices
- Receive unsolicited write commands from Allen-Bradley devices.

The DIGITAL DAS for RSLinx supports the following Allen-Bradley PLCs:

- PLC-5
- PLC-2
- PLC-3
- PLC-5/250
- MicroLogix 1000
- · SLC 500 processor families

The DAS for RSLinx allows you to connect to Allen-Bradley Programmable Controllers via:

- DH+ and DH-485 with 1784-KT, 1784\_KTX(D) and 1784-PCMK boards
